1. From the parameter drop down menu, a user may select between the various parameter types that they would like to run a calculation for. A user has the ability to select any combination of parameters.

Tip: Selecting multiple parameters of the same type, expands the scope of the calculation. For example, selecting all practices essentially allows the calculation to be run at the organization level. While selecting multiple parameters of a different type, narrows the scope of the calculation. For example, selecting a provider and a practice site will only run calculations where that provider had an encounter at the selected practice site during the reporting period.



4. The list on the bottom left-hand side of the screen contains all parameters that were selected for the calculation. Using the scrollbar, a user may view all of them.

5. The reporting period and the date when the calculation was performed can be viewed here.


