Below are the 2025 publication dates for CRISP Reporting Services (CRS). On these dates, the CRS team will refresh reports with updated data and may release new enhancements or reports. Please note, these dates are subject to change due to data delays or quality issues.

TABLE 1: Data Release Schedule

Reports Released Around the First Full Week of Each Month:

All-Payer MD Hospital Case Mix Reports

- Maryland hospitals submit preliminary all-payer hospital case mix claims to the Health Services Cost Review Commission (HSCRC) 15 days after the end of each month and 60 days after the end of each quarter.
- Reports using this data include:
 - Multi-Payer Reporting Suite
 - Patient Total Hospitalizations (PaTH)
 - Pre/Post Reports
 - Readmission Tableau Reports
 - Public Health Dashboard
 - Avoidable Admission Report
- These reports are updated continuously with preliminary data, but final HSCRC regulatory reports rely on finalized data for official purposes.

Medicare CCLF Data Reports

- Reports generated using CMS Claim and Claim Line Feed (CCLF) data include:
 - Maryland Primary Care Program (MDPCP) Reports
 - CCLF Medicare Analytics & Data Engine (MADE)
 - Medicare Performance Adjustment (MPA) Monitoring Reports
 - Care Transformation Profiler (CTP)
 - Care Redesign Program (CRP) Management Interface
- o The latest month of CCLF data is indicated for each reporting module.
